Re: Salty Dog 6 Hour Enduro Mountian Bike Race May 15, 2016

Skookum Cycle & Ski Ltd. is planning for the 15^{th,} annual Salty Dog 6 Hour Enduro race this May 15, 2016. Over the past years, the City of Salmon Arm administration office has help facilitate this event. We are looking for approval, once again from Mayor and Council of the City of Salmon Arm: for the use of the South Canoe trails and lower Malibu trail area to run this event. Including use of 10th Ave and from 60 St to 70 St for the mass start out of Klahani park.

In the mass start we are looking to string out 250-300 riders over 2-3km, and want to use the same start format as in past years. Start in Khalani park, go left up 10th Ave all the way into the South Canoe trail system. The road will be managed by six flaggers with radios. Two flaggers will be at the top, two in the middle, and two at the Klahani park entrance. The start takes about 15 to 20 minutes, after which 10th Ave will be open for regular traffic use; in past few years 10th Ave has been re-opened by 10:20. We are requesting special road use from 9:55 to 10:30am. In the case of an emergency during the start, event volunteers will move cyclists off the road to let emergency traffic by.

Review of the event:

The race uses the South Canoe bike trails, the old MOT gravel pit for parking, the lower part of the Malibu trail system for the start/finish area, 10th Ave for the mass start at 10 am, road signage and barricades borrowed from the City of Salmon Arm public works, and approximately a hundred local volunteers.

This year's race will sell out again in 8 to 10 hours, via online registration. We are planning for 650-700 riders, of which 450-500 will be from outside the Shuswap. Each rider brings on average 1-2 people with them for race support or just to visit Salmon Arm as a weekend get away. This race attracts people from Canmore, Calgary, Banff and Edmonton, from Vancouver and lower mainland, to North Western US, Alaska, Ottawa, and of course from all the interior BC cities. Last year the estimated number of people in the start finish area was between 1200-1500. As an economic driver, each person stays in Salmon Arm for 1.5 to 3 days, and will spend on average \$170 each per day. This is money spent on gas, food and

accommodations; dollars injected into our community before the summer busy season.

The Salty Dog race is a dynamic cycling event, and encourages the whole family to participate, with multiple races running simultaneously. Two Salty Pup 30 minute enduro events for kids aged 3-10, we usually have 100-130 participants biking around the bottom of the Malibu trails. The U15 Salty Dog 3 hour enduro, which has 100 people riding the logging road and the lower Malibu trails. The main event, the Salty Dog 6 Hour Enduro in which we will have 500 people racing, the 6 hour racers use the lower South Canoe trails to ride on. Event supported by the local back country first aid responders, Larch Hills Jr Nordic racers, CSRD, Shuswap Trail Alliance, Shuswap Bike Club, bike industry support staff volunteers, and the 100 plus race day volunteers.

In addition to the Salty Dog, we have added Friday and Saturday events to our weekend schedule. Events include: bike movie, kids bike parade, Rheinecker Creek group ride, Salty Street Fest downtown, petting zoo, live music, and much more! Our goal is to increase tourism dollars spent in our community over the weekend, creating an early season economic impact.

Over the years as the event has grown, the Salty Dog planning committee has constantly been adjusting our set of professional race requirements. Both event based and community logistical challenges. These include the following: trail usage and race course layout, parking, local resident communication, start finish area set up, professional timing, first aid, internet based registration, coordination of a large number of volunteers, bathrooms, neutral support for racers, garbage and recycling, and a number of other race specific details. As different challenges have occurred over the years, the Salty Dog planning committee has been able to resolve the issues in a positive and efficient manner.

Skookum's race resume includes planning, organization and execution of more than a dozen competitive mountain and road bike races over the past twelve years, including a Cycling BC sanctioned BC Cup points road race, four BC Masters road cycling races, nine annual Salty Dog Enduro mountain bike races, and Stoked to Get Spanked mountain bike races in Revelstoke. We have successfully liased with the following in the execution of these events: City of Salmon Arm, Township of Spallumacheen, CSRD, Ministry Of Transportation, RCMP, Ministry of Forestry, City of Revelstoke and Cycling BC. We look forward to a continued positive supportive working relationship with these groups.

A copy of our insurance certificate will be forwarded closer to the event date, on which the City of Salmon Arm, Ministry of Forests, Ministry Of Transportation (old gravel pit in Salmon Arm), and Skookum Cycle and Ski ltd Salmon Arm are all coinsured in the amount of five million dollars. Please let me know if you need any additional information as we finalize our planning.



Hello Shuswap Food Action Co-op members and supporters.

WE NEED YOUR SUPPORT on a very important issue: SFAC is attempting to encourage the CSRD (regional district) and/or the City of Salmon Arm to pursue a funding opportunity that supports food security in the region. The time line is very short (weeks), and the opportunity is great (\$45.000 from Interior Health over three years).

Please read the funding opportunity below, and if you are in support of our effort, please REPLY ASAP TO THIS NOTE with a YES in the subject line, meaning YES, I support the SFAC initiative, YES, I am in favour of food security in the region, and YES, I want to see our area representatives pursue this funding. I will tabulate the results for the *Thursday meeting. As well, I will update you later with all of the initiatives that SFAC has undertaken within the past year.

For those who are able to attend, SFAC will be presenting their position to the CSRD board at the regular PUBLIC meeting (in their new facility on the Salmon Arm lakefront) on **Thursday November 19th at 10:00 a.m. We invite** all supporters to come and support us in person.

Briefly, the Initiative (The **Community Food Action Initiative** Funding Guide for Local Government) is from **INTERIOR HEALTH.** FYI, a short summary of same:

Objectives of Funding

- ullet Development of a food security plan (1,2) and adoption of the plan for implementation; or
- Implementation of an existing food security plan.

Three successful projects will each receive up to \$15,000 annually between April 1, 2016-March 31, 2019 for a total of not more than \$45,000.

Selection Criteria

Loi (Letter of Intent) with the following components will be given priority:

- 1. Outlines a clear process of how a food security plan will be developed.
- 2. If a plan or strategy already exists, a clear process of how implementation will be undertaken.
- 3. Local government provides matching investment for the duration of the project. Reasonable in-kind contributions are acceptable but committed monetary contribution is preferred.



- 4. A multi-sector community group is formed to help guide the development or implementation and community input will be sought.
- 5. The development and implementation of the plan will be embedded in a local government planning process, eg. a Regional Sustainability Plan, or Official Community Plan, or Social Plan.
- 6. The plan will build upon work done in the community.
- 7. Projects applying for development of the food security plan will be expected to commence the implementation process prior to the end of the CFAI funding period. Projects applying to implement an existing food security plan will be expected to meet targets in the implementation process submitted.

I'm hoping you'll **reply YES** to this note today, and here is a thank you in advance for your support, Ronn Boeur (SFAC board member)

To: The City of Salmon Arm - Please file this as my Submission Request Supporting:

- 1.) a Salmon Arm Cell Tower Siting Consultation Policy based on independent scientific research.
- 2.) the commencement of the Removal of Cell Towers already placed in Dangerous Residential Locations.
- 3.) a Public Forum with scientists disclosing adverse biological health effects to humans, fauna & flora.

I am a local citizen of Salmon Arm and/or the CSRD and/or travel to and/or work here. I am aware that microwave radiofrequency radiation (wireless) emissions are not safe. Further, I am aware that the World Health Organization in 2011 designated all such wireless emissions as a Class 2B possible human cause of cancer, and there are also thousands of peer reviewed scientific studies showing multiple forms of adverse biological effects to humans, fauna and flora.

I am specifically concerned that:

- 1) Bees are affected & risk colony collapse from wireless emissions exposure at hive & pollination areas.
- 2) Children and pregnant mothers are at special risk of long term adverse health effects.
- Cell Tower emissions can be hazardous to the health of birds, livestock, amphibians and interfere with bird migratory patterns.
- 4) Loss of property value (estimated at 30%) for those residences in close proximity to a cell tower.

THEREFORE: <u>I am wholly opposed to the current placement of cell towers</u> in my Shuswap community which risk serious health impacts on humans & other living systems both in business & residential areas.

Radiation from towers placed in Salmon Arm can affect the CSRD and vise versa, and are magnified in intensity by the lake. They affect the travelling, shopping and/or working public, in both areas. Radiation knows no boundaries.

I support the Cell Tower Consultation Policy such as Salmon Arm is initiating only as long as it truly addresses the health issues. Health Canada's Safety Code 6 only addresses thermal effects not biological effects which includes cancer, thus critical health issues are not being addressed by this code.

The radiation from the 2 Canoe Towers being built now, honours no boundaries and will radiate much of Sunnybrae, their frequencies magnified over the water body. Citizens of Sunnybrae, Canoe and other affected areas have not been notified. Google 'The Brazilian Study' which backs up global research that radiation, within 500 meters of Cell Towers, is deadly causing Cancer rates to soar. Dangers exist even miles away. Additional research www.citizensforsafetechnology.org.

I REQUEST that our local government begin the process to remove and restrict cell towers and all microwave radiofrequency radiation antennae (such as those on low level power and utility poles), in downtown and residential areas, near schools, hospitals and care homes, which have been deployed without full and unrestricted public consultation process, and without any consideration for biological health effects.

It is the responsibility of local government to take appropriate action when they are notified of the possibility of potential harm to their public. They do have power ... and more, with their citizens backing them.

I FURTHER REQUEST that a public forum be organized whereby scientists from both sides of the wireless controversy speak to the public with no restriction on information, these scientists (or their institutions) to receive no funding from the telecommunications industry, and full disclosure of the adverse biological health effects from microwave radiofrequency radiation are to be presented.

Remembering Working People: Plaques Around the Province Project

In 2010, the BC Labour Heritage Centre
partnered with the Vancouver Convention Centre
on the installation of a series of educational panels
along the interior and exterior of the new
Convention Centre. The Convention Centre
covered the cost of producing the panels and we
provided the research.



A series of plaques documenting events and people in British Columbia's labour history are on display at the Vancouver Convention Centre.

Building on this success, the Labour Heritage Centre has launched the "Remembering Working People: Plaques Around the Province Project". Our aim is to extend the Convention Centre program to areas outside of Vancouver.

We are seeking nominations of events, groups, individuals and places throughout the province that demonstrate the contributions of working people to the history of British Columbia.

Our criteria includes, but is not strictly limited to:

- defining events, actions, episodes, movements, or experiences that played a significant role in the history of the labour movement and working people in British Columbia
- groups and individuals that made a lasting contribution to labour and working history
- places that hold a direct association with a significant aspect of BC or Canadian labour history

When proposing a suitable event and location for a plaque, nominators will be asked to consider locations where they will be accessible to the public and contribute to an understanding of the foundations laid by working people in the province's history.

The Labour Heritage Centre will cover the cost of research and promotion of each plaque, including links to background materials on our website.

Costs

We have chosen Ornamental Bronze, located in Richmond, to produce the plaques. Ornamental Bronze is a union shop and their product meets our primary requirement for longevity. They produced the 2010 plaque for the commemoration of the On to Ottawa Trek, shown at right. The size of this plaque is 18" x 29". Each cast bronze plaque is individually crafted and will

cost \$3,000 - \$5,000; depending on its size and complexity. We are asking nominators to contribute at least one-third of the cost of each plaque.
