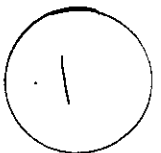

An open letter to Mayor Nancy Cooper:

I recently became aware of the City discussions to demolish a historic property in Salmon Arm. It seems odd that such discussion could even take place considering the value people put on places of historic value. I lived in Winnipeg until three years ago and ironically, it was only the coming to the City twenty years ago of American movie making that made Winnipeggers see the unbelievable riches in their historic buildings.... However, since then, many beautiful old properties have been saved and refurbished to their original splendour, assisted by the Winnipeg Historical Society and creative entrepreneurs.

Because Salmon Arm is a relatively young city, it is clear that we must be vigilant to retain older properties such as the historic house up near the current swimming pool. Setting a short deadline to oppose the destruction of this house is not seemly of a progressive City Council nor of Councillors who must listen to their citizens. I cannot help but admire the column "From the Archives" in The Observer each week, and the influence stores like Askew's has in this city over the years. Did they tear down their older store in order to build a more modern one? Not at all, because there is a sense of longevity in this community which they respected. I also notice the number of residences for elderly people here, and surely, these citizens deserve the satisfaction of seeing a new use for the house in question. Several times, the Piccadilly Mall has been the site of a thriving display of antique tools and crafts, and yet the stores in the mall thrive right alongside the displays of yesteryear items and activities.

In the February 8th Observer, I read the headline "Salmon Arm Celebrates Historic Roots", and the entire page is given to the accomplishments of the Haney Museum, and what a wonderful attraction it is for both visitors and residents of Salmon Arm. I would respectfully suggest that City Council may be missing the opportunity to create a thriving attraction for our City in Orchard House. Recently, friends in Kelowna celebrated their Valentine's Day with dinner at The Yellow House, a heritage building in downtown Kelowna. Surely there might be an entrepreneur in this town who would be interested in opening a tea room, even just in summer months, in Orchard House for visitors and residents who are attracted by the loveliness of this spot. Friends in Winnipeg can hardly wait to come here to visit me because I have told them bits and pieces about the landscape, the lake, the community of people, new friends, strawberry teas at First United, the exquisite summer floral show on so many streets executed by the City... we have a gem of a city here, and it's partly because of the historical areas and traditions of the city.

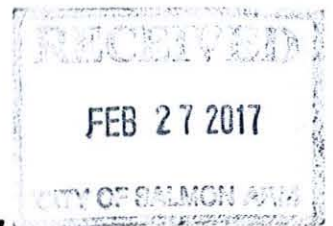

However I feel the limited time of two hours is far too short for the many citizens that may wish to attend. I think you could consider two full days on a weekend. I was also encouraged to see opinions by other supporters for a plan to relocate the large structure to another place on the lot and call upon interested people to donate to a fund to reduce some of the cost. We have already lost the Mcguire house last year and should attempt to make some effort to preserve what little history the town has left. Council must recognize that it was due to the great labour by our ancestors of the past that we can learn a wise design for our fair city in the future. If there is a call for public funding to preserve the Orchard treasure I'll gladly offer 500 bucks for a good start. Please think it over Nancy and debate same with your council.

The Observer just this week has further public complaints regarding accidents on our main street and number 1 highway! Two big semys involved and the sad death of a baby. There were a number of suggestions to increase traffic lights or to restrict left turns etc. and Council for lack of a better response agreed to revisit an ICBC study done in 1913. I myself have lived some ten years in Salmon Arm and over that time the main street congestion has at least doubled.

In Julytime in summer we have to suffer all the holiday traffic from Alberta together with 1000 Trailer-trucks a day on our main street. For safety alone Council will just have to plan with longtime vision to alleviate this problem which only grows worse every year. With a bypass across the bay as I have said often, we'll gain some valuable water front while the CPR and truckers will save endless time and money and traffic will avoid all the perils of stop lights and congestion. Use everyday safety as good reason to involve both the Feds and the Province. And please for heavens sakes forget about wasting a further half million dollars on that ridiculous engineered plan for the underpass.

Dear Mayor and Council,

In my opinion, it would be a very short-sighted thing to demolish the Orchard House/Dilkusha. Unlike cities like Armstrong, Nelson, Victoria and even little Enderby to the south, Salmon Arm really doesn't have that many heritage buildings. Some buildings like the old courthouse and the two old post offices have been preserved and they add a great deal to the character of Salmon Arm but, unfortunately, others have disappeared. A beautiful old house on Foothill Road that was destroyed when a subdivision went in on the same land is one example. There was also a beautiful house on Harris Street that was purposely neglected by the owner until it was in such disrepair that it had to be torn down.

I invite you to explore "big, bad Kelowna" and see for yourselves the number of houses that have been preserved. Many of them are quite modest dwellings but they have plaques in front of them with their names and information.

The old Bennett house is one example of a house that was preserved while upscale townhouses were built around it. An article in the February 15 issue of the Kelowna Capital News concerns an award given to the Central Okanagan Heritage Society which is celebrating its 35th year of "working to preserve the region's architectural history and to provide public education programs about heritage conservation and restoration." The article also talks about the Thompson House on Richter Avenue. A house adjacent to Sarson's Beach was donated to the city by its owners and now serves as a seniors' centre for the Mission area. While it is not as old as other houses here, it is a good example of a repurposed residence and someday its 1950's West Coast style may be valued as well.

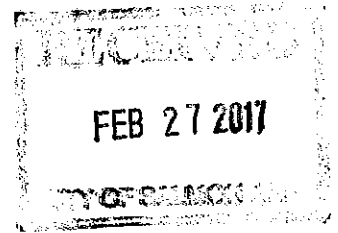
There is the Mackie House in Vernon as well as another one that was owned by an artist/teacher whose name escapes me at the moment. There is also the beautiful house that anchors the Sorrento Centre. Just yesterday, I happened to read an article in a publication for restaurant owners concerning the City of Calgary turning the Deane House there into a restaurant. Coincidentally, my older son recently mentioned that he and his wife had enjoyed lunch at a restaurant in a heritage house in Calgary. I am curious to find out if it was the Deane House.

The Orchard House is very close to the arena and curling rink and I think that a well-run, adult-oriented restaurant might be a viable option. (Perhaps Rickaby's could be enticed back to Salmon Arm.)

Please don't "disappear" another one of the few heritage buildings in Salmon Arm!

To Mayor Nancy Cooper and council:

I've been meaning to write with my feedback on a couple of subjects and have now been inspired by the 'Open letter to Mayor' by Sheilah Land in the Feb 24/17 Shuswap Market News regarding saving the Orchard House property.

I will address this subject first.

I, like Sheilah, moved to Salmon Arm 3 years ago and couldn't help but notice the lack of 'heritage' homes when I was house hunting. I didn't want one but noticed there weren't many. I moved from Ladner, BC where restoration of heritage buildings was somewhat of a priority. In the early 90's I moved from Vancouver to Revelstoke and noticed a difference in mentality regarding older homes there. Many homes in Vanc at that time were being torn down whereas the older homes in Revelstoke were being restored and renovated.

I believe and support incorporating the Orchard House into the design of the expansion of the Rec Centre somehow. Could it be used in collaboration with Okanagan College? cooking classes? art classes? I am saying this not knowing the expansion plans for the Rec Centre.

The second, probably larger issue is the trucks rolling through town running red lights.

I live in the downtown core and cross the TCH all the time. My points on this will be made not knowing what plans or studies have been done regarding this in the past. Should the trucks be made to slow down to 30km? The flashing lights heading west to indicate the light is going to change are half a block away from the light! from what I can see. That doesn't give any driver much time to stop.

The other issue regarding traffic I would like to comment on is directed at other drivers who continuously make their left or right hand turns in front of pedestrians while the pedestrian walk sign is still up. Are they really in that much of a hurry. With these traffic issues, should there be a higher or more permanent presence of RCMP through this corridor to catch the offenders?

Branded as the Salty Street Fest, we will be seeking to more actively engage the 1200+ attendees of the Annual Salty Dog Enduro Mountain Bike event. Additionally, we want to well encouraging local Salmon Arm residents to come downtown and enjoy the festival and amenities.

The event will take place on Saturday May 13th from 10am to 3pm on Hudson Ave. We request the City's approval and assistance in order to create a safe and enjoyable event. Your support provides increased marketing opportunities for multiple local businesses, not-for-profits, local tourism and it will be a showcase of our downtown community. The event includes the Shuswap Bike Club's Bike Swap, Kids Run Bike Parade, In The Groove Kids & Shuswap's Children Association's Play Zone, Demille's Petting Zoo, 4H Club Scavenger Hunt, free outdoor concert 12-2pm, Pie Co Pie Eating contest, booths set up by Silver Star, Sun Peaks, Shuswap Trail Alliance, Shuswap Cycling Club, and various Bike Brand's and Vendors showing off 2017 product. 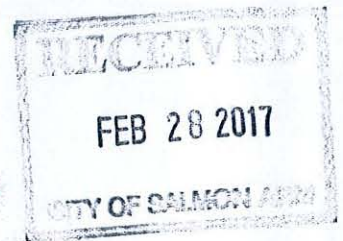

Thank you for supporting the profession of dental hygiene all across Canada and especially here in Salmon Arm.

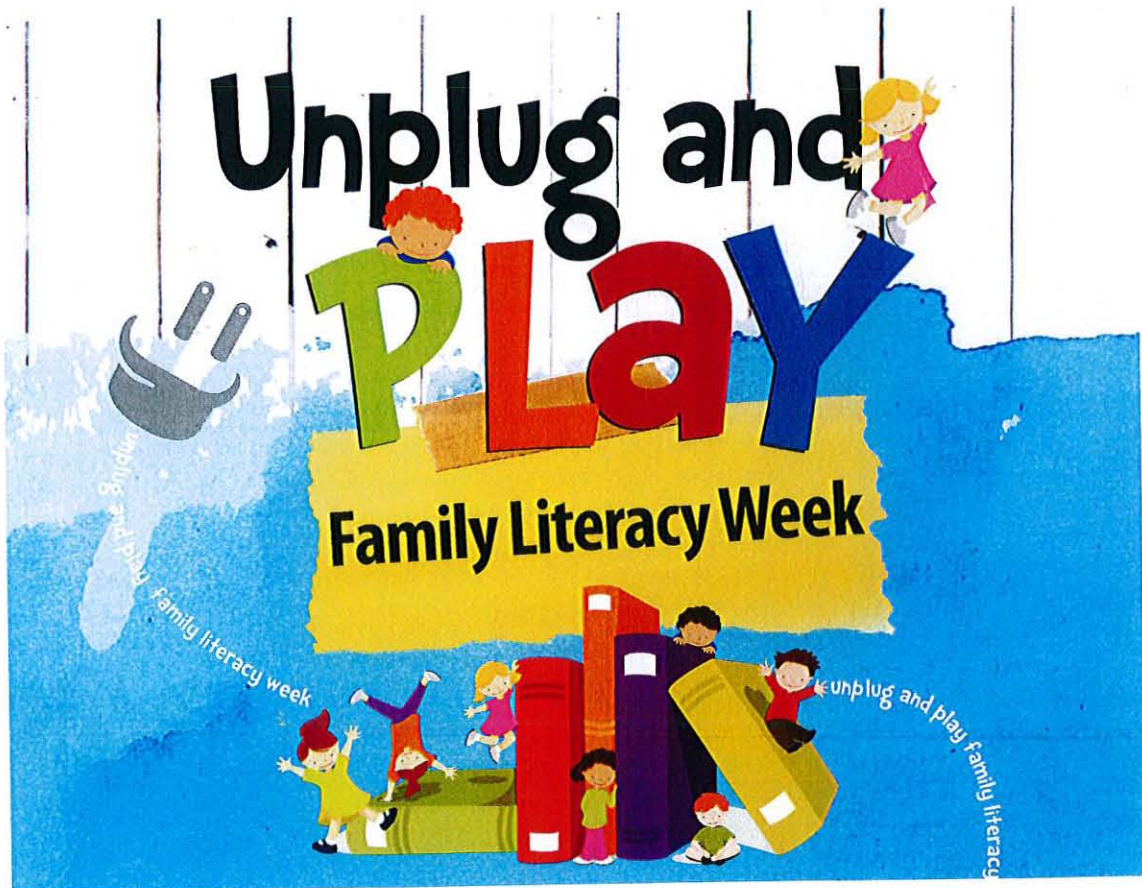

Carfentanil presence confirmed in Interior Health

The deadly drug carfentanil is now confirmed to be present in Interior Health. This comes following a positive carfentanil drug test in the Kootenay region reported by Health Canada and a positive carfentanil urine test in the Thompson Cariboo Shuswap region reported by LifeLabs. The drugs tested by Health Canada were illegal imitation oxycodone tablets with the markings CDN 80. The drug involved in the positive urine test is unknown.

"These recent findings confirm our suspicions and anecdotal reports that carfentanil is present in IH communities," said Dr. Trevor Corneil, Chief Medical Health Officer with Interior Health. "Carfentanil has also been detected in other parts of B.C. and may be responsible for the spike in overdose deaths seen at the end of 2016."

Carfentanil is a synthetic opioid normally used as a sedative for large animals like elephants. It is similar to fentanyl but can be 100 times more toxic; one or two grains the size of salt grains can be fatal to humans.

There is no reliable way for people to know with certainty if fentanyl, carfentanil or other potentially toxic components are in illegal drugs. People who use drugs are advised to abstain when possible, or to take measures to prevent overdose. Overdoses caused by carfentanil require larger quantities of naloxone and are more likely to be lethal.

Not using drugs at all is the best way to avoid overdose and other health impacts. Interior Health recommends people abstain from using any type of illegal drug, if at all possible. If abstaining is not an option, the following tips can help reduce the risk of overdose:

- Don't mix different drugs (including pharmaceutical medications, street drugs, and alcohol)
- Don't take drugs when you are alone, have a sober buddy with you. Leave door unlocked. Tell someone to check on you.
- Use less and pace yourself. Do testers to check strength - take a small sample of a drug before taking your usual dosage.
- Keep an eye out for your friends – stay together and look out for each other.
- Carry a Naloxone kit and know how to use it. A list of locations to get a kit can be found on the Interior Health [website](#).
- Recognize the signs of an OD: Slow or no breathing, gurgling or gasping, lips/fingertips turning blue, difficult to rouse (awaken), non-responsive.
- If someone thinks they may be having an overdose or is witnessing an overdose, follow the [SAVE ME steps](#) and call 9-1-1 immediately, do not delay.

Re: Request for partial exemption from District of Salmon Arm Noise Control Bylaw 1981 for Fishery Officer firearms training at Salmon Arm Fish and Game Club

Your Worship and Council members of the City of Salmon Arm

On behalf of the Federal Department of Fisheries and Oceans Canada (DFO), I wish to respectfully request permission to have a limited exemption from the time requirements of the District of Salmon Arm Noise Control Bylaw, 1981, specifically with respect to exceeding the 10pm time limit to no later than 11:59pm on April 25, 26, 27 2017 for the purpose of conducting firearms training at the Salmon Arm Fish and Game Club.

Fishery Officers employed by the Department of Fisheries and Oceans Canada are Peace Officers under the Canadian Criminal Code when conducting their duties under the Fisheries Act and/or its regulations. Fishery Officers are law enforcement officers that enforce Federal and Provincial laws related to the conservation of protection of fisheries resources in Canada. Fishery Officers are armed with sidearms and conduct standard annual training to maintain proficiency under the direction and supervision of trained firearms instructors, whom are also Fishery Officers employed by the Department of Fisheries and Oceans Canada. Firearms training curriculum requires that Fishery Officers maintain proficiency by training for scenarios that could potentially occur during the course of a Fishery Officers duties. As Fishery Officers often work at night in remote areas, they may be required to use their sidearms or other firearms to defend themselves, and/or to ensure public safety and to protect the public when working in any condition, including during times when it is dark or there is limited light. A training component has been designed to teach Fishery Officers how to safely use their firearms in low light and dark environments to defend themselves and/or to ensure public safety and to protect the public.

The low light component of firearms training has been identified as a requirement of the firearms training for Fishery Officers. Fishery Officers have booked the Salmon Arm Fish and Game Club from April 24 to 28th, 2017. It is anticipated that the Department of Fisheries and Oceans Canada may require additional time beyond the 10PM deadline as specified within the District of Salmon Arm Noise Control Bylaw, 1981 to complete the required training to ensure that there is a dark training environment. On April 24 to 28th the sunset times are just after 8 pm and it will be pretty dark 1 hour after. It is

anticipated that we will require an exemption from 10pm to 11:59pm on April 25,26, and 27th to complete the training.

Given the remote location of the Salmon Arm Fish and Game Club, there are very few residences within the close proximity of the range that could potentially be disturbed by the noise. Fisheries and Oceans Canada would be prepared to consult with the potentially affected residents to inform them of the dates, times and duration of the expected noise that may fall outside of the noise bylaw times specified in any manner the City feels appropriate including, including; posting notices in the area, sending information by mail or deliver information in person, and/or post notification in the local newspaper(s) if so requested.

In consideration of the foregoing, I respectfully request that Fisheries and Oceans Canada and it's employees be granted a temporary exemption from Section 4 of the District of Salmon Arm Noise Control Bylaw, 1981 on April 25, 26, 27 from 10:00 pm to 11:50 pm each day. And that the Salmon Arm Fish and Game Club not be held liable under Section 4(b) for noise made by Fisheries and Oceans Canada Fishery Officers as per the times and other details as provided above.

4. General Regulations

a) No person shall on any day before seven (7) o'clock in the forenoon or after ten (10) o'clock in the afternoon make or cause, or permit to be made or caused, any noise in or on a public or private place which disturbs or tends to disturb the quiet, peace, rest, enjoyment, comfort, or convenience of any person or persons in the neighborhood or vicinity.

b) No person being the owner or occupier of any premises or of any real property shall on any day before seven (7) o'clock in the forenoon or after ten (10) o'clock in the afternoon allow or permit such real property to be used so that noise or sound which emanates therefrom, disturbs or tends to disturb the quiet, peace, rest, enjoyment, comfort, or convenience of any person or persons in the neighborhood or vicinity.

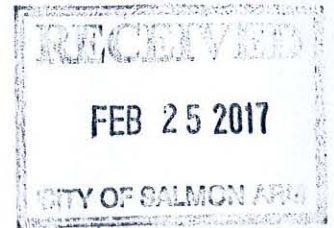

This is a walkathon which was started in the town of Malvern, ON., in 2003 by the Parent Council of the Sathya Sai School of Canada, a private elementary school, registered with the Ontario Ministry of Education. Re: Provincial Private Moorage Program

At their meeting held February 14, 2017, The District of Coldstream Council adopted the following resolution:

THAT the Ministry of Forest, Lands and Natural Resource Operations amend the Provincial General Permission for the Use of Crown Land for Private Moorage to explicitly require that a General Permission for private moorage requires compliance with any local government regulation pertaining to the construction, placement and use of private moorage;

AND THAT Front Counter BC reinstate its practice of referring Private Moorage applications to municipalities;

AND FURTHER THAT if the Ministry does not amend the Provincial General Permission for the Use of Crown Land for Private Moorage, that the Thompson Okanagan area be designated an "Application Only Area".

The District has forwarded this resolution to the Southern Interior Local Government Association to seek support at the 2017 Annual Convention with the intention of presenting this resolution at the 2017 UBCM Convention. RESOLUTION TO THE
Southern Interior Local Government Association
(SILGA)

Provincial Private Moorage Program

District of Coldstream

WHEREAS the Ministry of Forests, Lands and Natural Resource Operations has amended the private moorage program permitting residential docks to be authorized under a "General Permission" rather than an application-driven Crown land tenure;

AND WHEREAS residential docks authorized under a "General Permission" will not require a referral to the local government for compliance with local government requirements:

THEREFORE BE IT RESOLVED that the Ministry of Forests, Lands and Natural Resource Operations amend the Provincial General Permission for the Use of Crown Land for Private Moorage to explicitly require that a General Permission for private moorage requires compliance with any local government regulation pertaining to the construction, placement and use of private moorage;

AND THAT Front Counter BC reinstate its practice of referring Private Moorage applications to municipalities;

AND FURTHER THAT if the Ministry does not amend the Provincial General Permission for the Use of Crown Land for Private Moorage, that the Thompson Okanagan area be designated an "Application Only Area".

BACKGROUND INFORMATION

Under the previous process applications for a dock approval included a form of tenure for the area of the waterbody where the dock was to be located. Previously a person would receive tenure over the area, usually for a ten-year period of time. Through that process the local government would receive a referral to confirm compliance with use and dock dimensions. If the local government's requirements were satisfied and the dock met provincial guidelines, tenure would be granted and the dock permitted.

Under the new General Permission standards, tenure is not granted; the property owner has the right to install a dock on the water provided it meets the provincial guidelines.

One of the conditions to comply with the General Permission is that the dock has to comply with any local government requirements. Unfortunately there is no check at the provincial level to see if it complies, nor is there a referral to the local government for comments.

When an application is submitted to the province, provided it meets provincial requirements and environmental criteria, the owner will be advised that they can construct the dock. That approval is conditional to the dock meeting local government requirements.

The onus is then on the property owner to check with the local government to make sure the local government requirements are met.

This creates a scenario where people will believe they have what they need once the province "signs off" and may not check with the local government for their requirements.

It would be better for all parties if the province were to continue to refer applications to the local government prior to allowing the General Permission.


