Re: Traffic on 5th St. SW (Between Blackburn Park and Fairgrounds)

Dear Mayor and Council:

I am writing on behalf of a large group of parents who are concerned about the frequency of speeding along 5th St. SW – specifically the stretch between the fairgrounds and Blackburn Park. With the arrival of spring, parents and their children, as well as youth using the skate park, are heading to Blackburn Park in high numbers. Many dog owners also make regular use of the off-leash area on the fair grounds. In short, on a fair weather day, there are small children, youth and dogs getting in and out of cars all along 5th Street. It is not uncommon for one caregiver to be unloading multiple children, strollers and pets from a vehicle. With the new spray park, these numbers are only set to increase as we move into summer.

Despite the fact that this stretch of road is located within a park zone, vehicles regularly speed through this area. Many parents have experienced or witnessed close calls. It is only a matter of time before a child or pet is seriously injured.

It is unclear what the best course of action to tackle this problem would be, but we all agree that something must be done – and the quicker the better. Perhaps council should request that the RCMP set speed traps more frequently. Another action might involve installing a flashing speed sign that alerts motorists when they are speeding (i.e. similar to what is on Lakeshore Road), or speed bumps. A more radical solution might involve restricting entry to this street from one side.

Thank you for taking our concerns into consideration.

I think this also leave a beautiful legacy for Salmon Arm on Canada's 150th for inclusion and connections. Something to celebrate!



More buses requested Petition: Riders want longer hours, Sunday service.

More than 250 Salmon Arm citizens have asked the city to increase bus service for the community.

Mike Caley of Shuswap Connextions, a self-advocacy group dedicated to removing barriers for people with disabilities and educating others, circulated a petition regarding bus service. The petition, with more than 250 signatures, asks that busing hours be increased to 9 p.m. on weekdays and bustravel be offered on Sundays.

"There is insufficient busing hours for the amount of residents, especially seniors and people with disabilities who have no other means aside from the city bus to get around in our community," the petition read.

Council discussed it at their April 27 meeting:

Coun. Ken Jamieson

noted the issue of transit comes up frequently, is important and council will take the message to BC Transit. . Coun. Alan Harrison acknowledged those who signed and said he wants them to know that the province has pulled back on its share. While it used to be about a 50-50 split for improvements, the city now has to shoulder 100 per cent of increases.

"We've seen across the province, cities not adding to their fleet. One hundred per cent is too expensive and that's going to make it more difficult."

Coun. Chad Eliason noted transit is important to many people in the community and is not a luxury serivice.

"I think it's time we start looking at 'made in Salmon Arm' solutions," he said, suggesting the school district and the city consider sharing costs and almagamating services. "We need to look

at new and innovative ways."

At the meeting, council approved the 2015/2016 operating agreement between the city, FirstCanadaULC (the contractor providing the service) and BC Transit. City staff explained that it's a master agreement that allows the city to work with the contractor.





UPDATE: Caution for water users on Shuswap Lake near Cape Horn

Interior Health is advising residents along the western arm of Shuswap Lake to be cautious and check their water for any signs of diesel fuel (either a sheen on the water surface or any smell) after receiving a report that a logging tug boat containing approximately 4,000 litres of diesel sank on the afternoon of May 15. The tug sank near Cape Horn which is North West of the Cinnemousun Narrows on the main arm of Shuswap Lake.

Evidence of a small amount of fuel is now visible on the surface of the lake in the area where the tug sank. Crews are currently on scene with divers working to contain and remove the tug before any further fuel can spill.

Any residents in the area should avoid using the water if it smells or tastes like fuel or if there is fuel visible in the water. This means no drinking, showering/bathing or brushing teeth if a fuel odour is detected. Diesel fuel can pose a health risk following ingestion, inhalation or skin absorption.

This advisory is a precautionary measure to ensure individuals in the area are aware of the potential risk given this incident. Interior Health has contacted community water supply systems along the lake within 10 kilometres of the spill.

Interior Health will remain in contact with the Coast Guard, Ministry of Environment and the Columbia Shuswap Regional District regarding this advisory.

IH issues water advisory following tanker truck accident near Shuswap River

Interior Health is advising residents along the Shuswap River from about 6 kilometres east of Ashton Creek to the mouth of river at Mara Lake to be cautious and check their water for any signs of diesel fuel. This advisory comes after Interior Health was notified that a tanker truck crashed near 1435 Enderby Mabel Lake Road this morning, spilling up to 4,090 liters of gasoline and 12,500 litres of diesel into a flooded field adjacent to the river.

It is unclear at this time if fuel has entered the river. This is a precautionary advisory for water users in the immediate area of the spill and those along the Shuswap River downstream from the accident to the mouth of Mara Lake. There is no risk from this spill to water systems upstream from where the accident occurred.

See attached map of the impacted area.


Any residents along the river in the impacted area should not use water if it smells or tastes like fuel or if there is fuel visible in the water. This includes no drinking, showering/bathing or brushing teeth if a fuel odour is detected. Diesel fuel and gasoline can pose a health risk following ingestion, inhalation or skin absorption.

Interior Health has contacted community water system operators in Enderby and Grinrod. Both systems draw water from the river and the operators are taking steps to ensure their water users are protected.

Ministry of Environment and environmental consultants are responding to contain the spill. Interior Health will be monitoring this situation and provide updates as new information is available.

Bat encounters can put you at risk for rabies

Some people think they are cute and others find them creepy. Whether you are fascinated or fearful, the bottom line is it's important to avoid coming into physical contact with bats, the primary carrier of the rabies virus in B.C.

Rabies is a very serious disease that affects the nervous system. It is almost always fatal if not treated in time. In 2016, 61 people in the Interior Health region were treated for potential exposure to rabies.

Between four and eight per cent of the bats that are tested after coming into contact with people are found to have the rabies virus. Infected bats can transmit rabies to humans when their saliva comes into contact with a person's mucus membranes (eyes, nose, and mouth) or through a break in the skin.

With the long weekend just around the corner, many people will be bringing summer gear out of storage or heading out to open the cabin. Activities like these can lead to unexpected encounters with bats. Bats often fly into poorly sealed cabins and homes, they roost in attic spaces and they can even be found hanging inside closed patio umbrellas.

Interior Health offers these tips to help protect yourself and your family:

- Never touch live or dead bats. Tell children not to play with or touch bats.
- Make your home or cabin "bat proof." Keep doors and windows closed, make sure window screens don't have any holes, and keep the attic area free of bats by keeping all vents properly screened and by closing off other openings.
- If you find a live bat in a room of your home, open the window and close interior doors until the bat leaves.
- If your home or workplace is inhabited by bats, seek professional bat-control advice from a pest control or wildlife specialist. Bats are a protected species under the BC Wildlife Act. Excluding or evicting bats from their roost site so they move to another roost is the best way to remove bats.
- Avoid locations or activities where bats are likely to be found (e.g., caves).
- If you have a pet dog, cat, or ferret, make sure they are vaccinated regularly against rabies. Pets that were born and raised in B.C. pose a very low risk of transmitting rabies to humans; however, vaccinating your pets will protect them from rabies. If your pet has come in contact with a bat, contact your veterinarian to discuss the risk of rabies to your pet.

All contact with bats should be taken seriously. Bats have tiny sharp teeth and claws, so scratches or bites may not be visible or painful but could still be there. If you have been bitten or scratched:

- Thoroughly wash the wounds with soap and water.
- Contact your local public health unit or family doctor immediately. Do not wait for symptoms to appear.
- Call a wildlife or pest control company to capture the bat. If trying to capture the bat yourself, avoid contact by wearing leather gloves, a hat, long sleeves, and pants.
- Safely contain the bat in a secure, covered container to prevent others from being exposed. Keep the bat in a safe location until public health can arrange to pick it up and test it for rabies.

Early treatment is crucial to prevent rabies from progressing. Treatment involves a two-week period of vaccinations that must be administered as soon as possible after exposure.

San Diego State University completed a study regarding the long term negative effects of cigarette butts: **"The study revealed that a single cigarette butt soaked in a liter of water for one day resulted in vastly diminished water quality and the death of 50 percent of the fish therein."**
