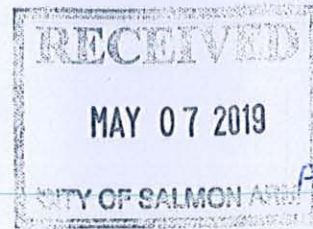

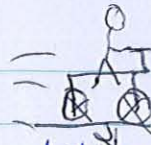

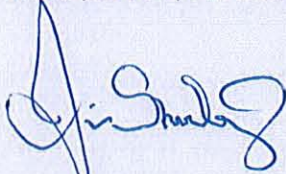
As indicated the bench is made of Granite and is of a very good quality.

Although there is currently a bench in close proximity to the requested location, Mr. Gerow indicates his staff could easily remove and relocate to another location in town.

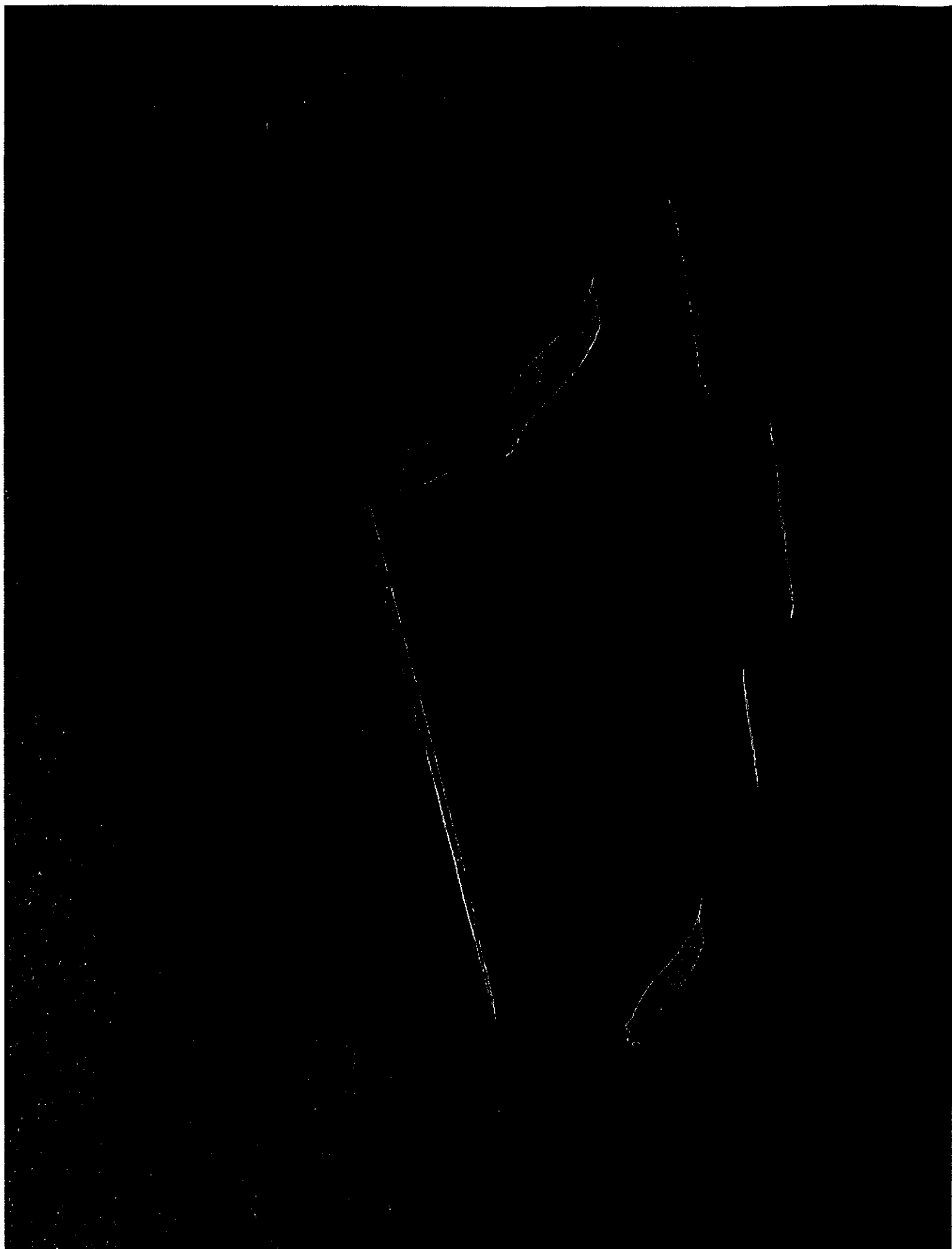

We, the owners of the properties (the "Properties") listed above, are writing to request that Salmon Arm Council reconsider the future "Service/Tourist Commercial" designation as defined in the Official Community Plan (the "OCP") for the Properties on the south side of 11<sup>th</sup> Avenue NE situated west of 18<sup>th</sup> Street NE to the intersection of 16<sup>th</sup> Street NE and return the future use of the Properties to R-1 zoning in the OCP when the OCP is opened for revision.

Section 9.3.18(c) of the OCP, in discussing the commercial corridor east of City Centre to 30 Street NE, states that "limited expansion of this area may be considered" and "may include convenience or small-scale food retail store, neighborhood pub, restaurant or cafe, commercial child care, office, personal service establishment, and upper floor residential." It is our contention that these needs are met by the current commercial establishments already in existence on 11 Ave NE east of 18<sup>th</sup> Street NE, including Askews' Uptown Store, Setters Pub, Home Restaurant, SASCU uptown facility which will include upper floor residential units, Comfort Inn, Super 8 Motel, MacDonald's Restaurant and the various stores and gas station in the small shopping centre on the upper south side of 11<sup>th</sup> Avenue NE. Given the level of commercial enterprises presently available in this area, we do not believe an argument can be made for more commercial enterprise to be developed on the Properties.

We make this request because we are currently being unfairly assessed under the Service/Tourist Commercial designation by the Assessor. The Assessor ruled that his assessment of the Properties is based on his opinion that the highest and best use of the Properties should reflect the Service/Tourist Commercial designation of the Properties under the Official Community Plan (the "OCP") of the city of Salmon Arm.

We have no interest in applying to rezone the Properties to Commercial, nor have we encountered any pressure to consider selling the Properties for commercial purposes. The Properties are rightfully presently zoned as R-1 by the City. The OCP future use should mirror this zoning and the Service/Tourist Commercial designation for the properties should be removed.

We are willing to appear before Council to discuss this request.

I noticed recently a post on social media that the Salmon Arm Council was planning on spending over 800K on renovations or repairs to the runways and taxiways at the Salmon Arm/Shuswap Regional Airport. The social media post was to encourage people to oppose this type of expenditure.

I am writing to support the expense and to ensure that the Salmon Arm /Shuswap Regional Airport is maintained to the highest standard.

The airport is not a facility that everyone uses but it is a facility that benefits the entire area. I believe that the airport has helped the local community economically through out the years. The original airport was out near the DeMille's farm and would be a concern now with all the proposed road work and growing community where as now, its current location is prefect for the city. It is close to downtown and all the amenities that Salmon Arm offers plus it is out of the way of the growing housing market. It is next door to the industrial park which makes it appealing to future organizations that may move to Salmon Arm.

I would like to see that the airport is maintained to such a standard that it can and will be operational 24 hours a day 7 days a week. I believe it was last year that I read an article that stated about 50 thousand dollars was needed to clear trees and such to allow night time landings and that the money was not spent. I would like to see things like that project to be completed before taxiway upgrades so that the airport can maintain a 24-hour status.

The airport is important to the community and please do not consider it as an expensive toy for a select few.

Benefits of an airport:

- Air Ambulance accessibility 24/7 (not all patients are evacuated via helicopter, many go by fixed wing aircraft).
- Current and future economic benefits to the entire community.
- Forest fire teams use the airport as a staging area during fire season. Those crews are put up in hotels and eat in local restaurants.
- Tourists. Tourists do fly into the Salmon Arm airport to vacation in the area.
- And many more I am sure of.

# POLICY MANUAL

Policy No. 8

**RE: YOUTH AT UBCM POLICY (updated May 9, 2019)**

**POLICY STATEMENT:**

It will be the policy of SILGA to reimburse up to 2 youth each year for the cost of travel, accommodation, meals and out of pocket expenses incurred to attend the UBCM convention.

**POLICY BACKGROUND:**

To promote youth involvement and interest in local government, SILGA will annually sponsor up to 2 youth to attend the UBCM convention. A call for nominations will be sent by SILGA after each annual convention to all SILGA members with the youth representatives chosen at the SILGA executive meeting on June 19, 2019. Deadline for nominations for 2019 is June 17<sup>th</sup>.

A SILGA member local government must first nominate a youth from their community. A brief statement written by the youth explaining why they want to attend along with a summary of their interests and accomplishments should accompany the nomination.

The local government of the selected youth will mentor them during the week of the convention. The youth will be requested to provide a written report to SILGA outlining their experiences and the impact the week had for them.

**Definition of "Youth"**

- School age secondary students registered in a public school, an independent school, Distributed Learning program or as a home-schooled learner
- up to the age of 19 on or after July 1 of the current school year

SILGA will spend up to \$5,000/year for the cost of this program. Receipts will be required. Sponsoring local governments are requested to cover the allocated conventions costs for the selected youth and then submit receipts to SILGA for reimbursement.

**POLICY DETAILS:**

1. Transportation:

- To pay compensation for air travel at the lowest available air fare; or
- To pay compensation for the use of private vehicles at the rate equivalent to that paid by the Province of British Columbia<sup>1</sup>, to a maximum of the lowest economy air fare.
- Only the driver is entitled to reimbursement for car mileage; the driver must submit the names of the passengers with the expense account.

2. Accommodation (due to weather conditions/distance travelled/  
other circumstances):

- To pay compensation for hotel rooms at cost and with a receipt required;  
or
- allowance of \$30.00 per night may be claimed (no receipts required).

3. Other Expenses:

---



- For all meetings and other authorized travel where required meals are not provided at the event, compensation for meals will be as follows:

Breakfast	\$15 including tips and tax
Lunch	\$25 including tips and tax
Dinner	\$35 including tips and tax

On the date of departure, travel must start before 7:00 am to claim breakfast; before 12:00 noon to claim lunch; and, on the date of return, travel must end after 6:00 pm to claim dinner.

- All other expenses occurred for hospitality expenses and other non-specified expenses shall be reimbursed at cost when receipts are provided, subject to Executive approval.

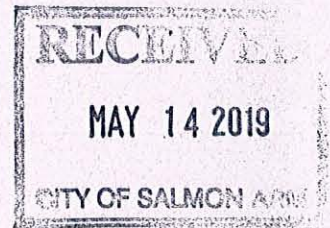

## Rogers informs Salmon Arm council of 2.6-metre antennae on downtown building as a courtesy

Salmon Arm council members expressed their appreciation for receiving notification from Rogers of cellular antennae to be erected on a building on Alexander Street.

At the city's May 6 planning and development services meeting, staff described the notification from Medallion Wireless, on behalf of Rogers Wireless. Rogers proposes to install "six initial antennas and one microwave, with room for three additional antennas in the future, comparable to what might be located on a cellular tower," according to a city planning report.

Coun. Louise Wallace Richmond said she has heard concerns from business about a big structure on the building and is pleased to see that it's not. She added she's happy to be informed.

The equipment will be placed on the roof of 320 Alexander St. NE, the building between the CIBC and Shuswap Clothing & Shoe Company, which houses several businesses including Crazy River Clothing Co. and the Montebello Dental Clinic.

No public consultation is required because the installation meets city criteria: locating antennas on an existing rooftop is a preferred location, as are areas designated commercial by the official community plan. Also, the proposed antennae are 2.61 metres in height and will extend 2.31m above the existing roof's parapet, which is less than the three-metre maximum recommended.

Marshall Rasmussen of Medallion Wireless attended the meeting and described the proposal as a minor installation.

Kevin Pearson, the city's director of development services, noted the company could go ahead and put the antennae on the roof without coming to the city.

"This is a courtesy."

Coun. Chad Eliason also appreciated the notification and credited the work the city has already done on cell tower installations with making the process straightforward.

"We did a lot of work on cell towers and cell tower installations, so when they come and want to work with us, there's not much to be done... I think we've done three cell towers in my time here."

He also said he thinks adding more capacity for cell service, which will increase time for productivity, is important for the downtown.

In a letter to the city, Rasmussen wrote that the purpose of the site is to respond to the growing demand for wireless voice and data communication services, such as mobile broadband and video service for use on smartphones, computer tablets and laptops.

Mayor Alan Harrison pointed out that the antennae on the downtown firehall across from city hall are significantly taller than the ones proposed for Alexander Street.

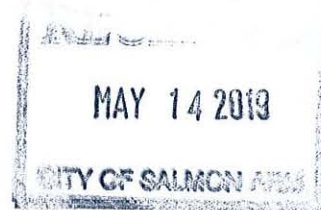

OPEN LETTER TO MAYOR HARRISON AND THE SALMON ARM CITY COUNCIL

Salmon Arm

Re: Sustainable shopping bag plan

Dear Mayor and Council:

On April 23, I attended the Salmon Arm City Council meeting on their idea to ban single-use plastic bags. Local business representatives present agreed with the idea, just needing time to use up current bags. I presented several samples of washable fabric bags, created locally from clean recycled materials to be sold by donation to The Smile Mission Oral Health Outreach Society, which is a local registered charity raising funds to lower barriers to accessing basic dental care in Salmon Arm. The meeting concluded with the Mayor and Council deciding to acquire 8- or 9000 multiple-use bags from (China?), to be distributed to households in Salmon Arm.

In hindsight, I question the wisdom of using Salmon Arm money to buy bags from China that will still be made with plastic. China's environmental regulations are less stringent, and those bags will still be in our landfill hundreds of years from now: this is contrary to the whole point of moving away from plastic. Getting things cheaper from China does not count all the costs, and our goal here is to stop polluting. Further: the plastic-coated multiple-use grocery bags do not survive washing well and, as any cashier will tell you, they get gross after a while. Using those plastic bags to promote Salmon Arm will be sending the wrong message: that we are cheap, short-sighted and do not care about the long-term effect of products we (cause to) produce.

Why not use what we have right here? We have an alternative that will send the right message. How about expanding the Smile Mission fabric bag project already in progress, which will give Salmon Arm residents unique, washable and long-term reusable shopping bags, employ local people and support improved access to dental care, and with that, population health? Here is potential for a new, clean industry right here in Salmon Arm. We start, and lots of towns will want this.

I already started by creating a sewing room downtown, we can create any bag the City wants out of locally sourced materials and there is lots of excellent fabric around that can be re-purposed for this. The Smile Mission fabric bag project has been well-received, "bags supporting dental care" are available locally and residents have come forward with cheers, material supports and offers to help.

The Smile Mission Oral Health Outreach Society is a Registered Charity helping local residents who have financial barriers to access dental treatment with dignity in regular clinics. Improving oral health improves population health, which makes this a win/win for everybody. Can we talk?

The concept spread to the District of Summerland in 2018 with the opening of [The Sharing Stand](#), and the Town of Oliver has its own [Harvest Hut](#) coming this summer.

The Board of Directors of the RDCK joined municipalities across Canada and around the world in formally recognizing the global and local state of climate crisis. 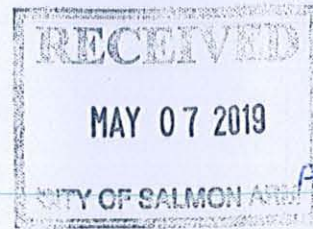

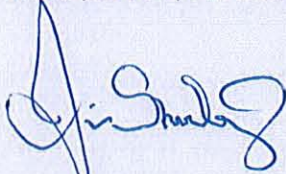
As indicated the bench is made of Granite and is of a very good quality.

We have met with Darin Gerow, manager of roads and parks and he has no concerns with this.

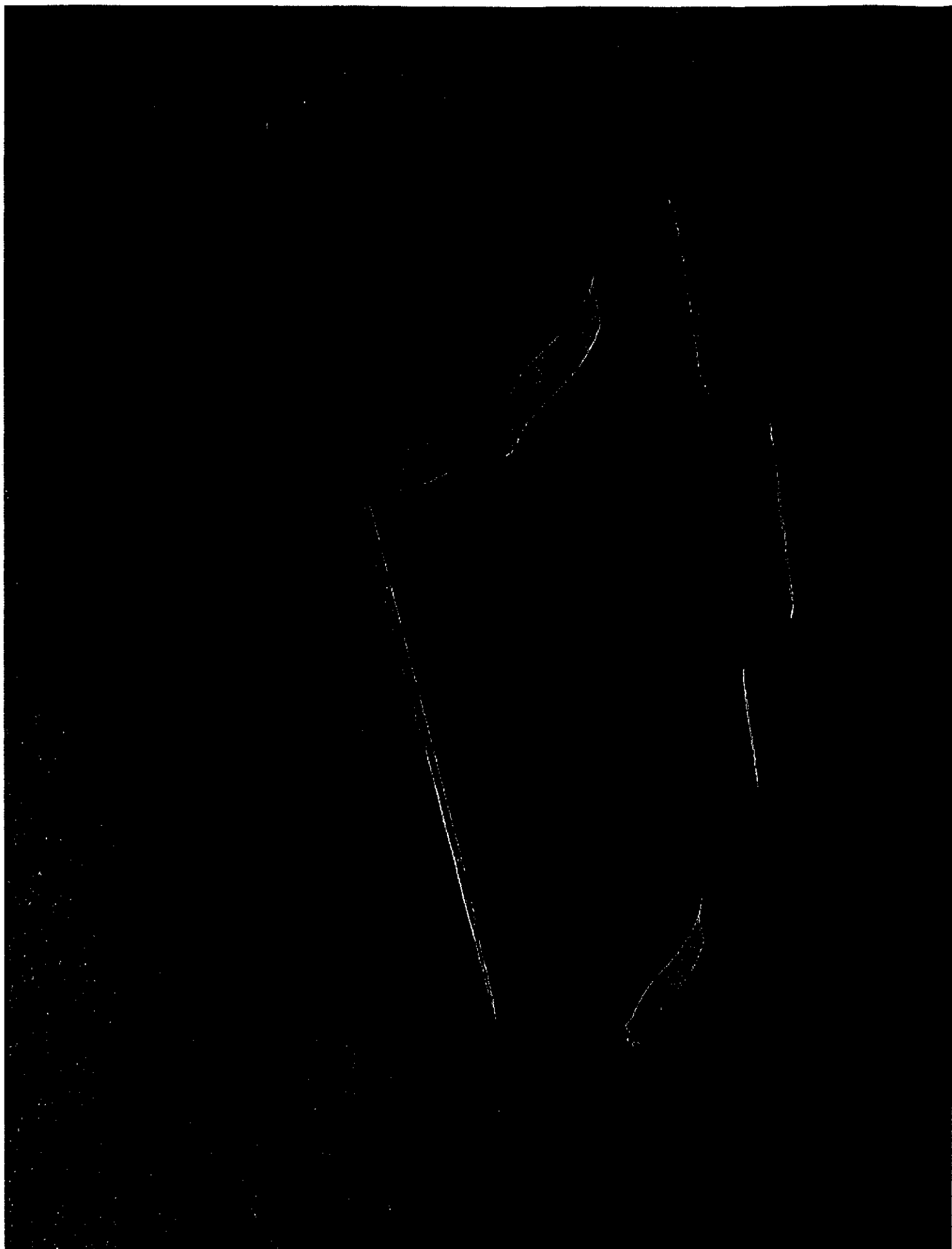
Although there is currently a bench in close proximity to the requested location, Mr. Gerow indicates his staff could easily remove and relocate to another location in town.

We, the owners of the properties (the "Properties") listed above, are writing to request that Salmon Arm Council reconsider the future "Service/Tourist Commercial" designation as defined in the Official Community Plan (the "OCP") for the Properties on the south side of 11<sup>th</sup> Avenue NE situated west of 18<sup>th</sup> Street NE to the intersection of 16<sup>th</sup> Street NE and return the future use of the Properties to R-1 zoning in the OCP when the OCP is opened for revision.

Section 9.3.18(c) of the OCP, in discussing the commercial corridor east of City Centre to 30 Street NE, states that "limited expansion of this area may be considered" and "may include convenience or small-scale food retail store, neighborhood pub, restaurant or cafe, commercial child care, office, personal service establishment, and upper floor residential." It is our contention that these needs are met by the current commercial establishments already in existence on 11 Ave NE east of 18<sup>th</sup> Street NE, including Askews' Uptown Store, Setters Pub, Home Restaurant, SASCU uptown facility which will include upper floor residential units, Comfort Inn, Super 8 Motel, MacDonald's Restaurant and the various stores and gas station in the small shopping centre on the upper south side of 11<sup>th</sup> Avenue NE. Given the level of commercial enterprises presently available in this area, we do not believe an argument can be made for more commercial enterprise to be developed on the Properties.

We make this request because we are currently being unfairly assessed under the Service/Tourist Commercial designation by the Assessor. The Assessor ruled that his assessment of the Properties is based on his opinion that the highest and best use of the Properties should reflect the Service/Tourist Commercial designation of the Properties under the Official Community Plan (the "OCP") of the city of Salmon Arm.

We have no interest in applying to rezone the Properties to Commercial, nor have we encountered any pressure to consider selling the Properties for commercial purposes. The Properties are rightfully presently zoned as R-1 by the City. The OCP future use should mirror this zoning and the Service/Tourist Commercial designation for the properties should be removed.

We are willing to appear before Council to discuss this request.

I noticed recently a post on social media that the Salmon Arm Council was planning on spending over 800K on renovations or repairs to the runways and taxiways at the Salmon Arm/Shuswap Regional Airport. The social media post was to encourage people to oppose this type of expenditure.

I am writing to support the expense and to ensure that the Salmon Arm /Shuswap Regional Airport is maintained to the highest standard.

The airport is not a facility that everyone uses but it is a facility that benefits the entire area. I believe that the airport has helped the local community economically through out the years. The original airport was out near the DeMille's farm and would be a concern now with all the proposed road work and growing community where as now, its current location is prefect for the city. It is close to downtown and all the amenities that Salmon Arm offers plus it is out of the way of the growing housing market. It is next door to the industrial park which makes it appealing to future organizations that may move to Salmon Arm.

I would like to see that the airport is maintained to such a standard that it can and will be operational 24 hours a day 7 days a week. **RE: YOUTH AT UBCM POLICY (updated May 9, 2019)**

**POLICY STATEMENT:**

It will be the policy of SILGA to reimburse up to 2 youth each year for the cost of travel, accommodation, meals and out of pocket expenses incurred to attend the UBCM convention.

**POLICY BACKGROUND:**

To promote youth involvement and interest in local government, SILGA will annually sponsor up to 2 youth to attend the UBCM convention. A call for nominations will be sent by SILGA after each annual convention to all SILGA members with the youth representatives chosen at the SILGA executive meeting on June 19, 2019. Deadline for nominations for 2019 is June 17<sup>th</sup>.

A SILGA member local government must first nominate a youth from their community. A brief statement written by the youth explaining why they want to attend along with a summary of their interests and accomplishments should accompany the nomination.

The local government of the selected youth will mentor them during the week of the convention. The youth will be requested to provide a written report to SILGA outlining their experiences and the impact the week had for them.

**Definition of "Youth"**

- School age secondary students registered in a public school, an independent school, Distributed Learning program or as a home-schooled learner
- up to the age of 19 on or after July 1 of the current school year

SILGA will spend up to \$5,000/year for the cost of this program. Receipts will be required. Sponsoring local governments are requested to cover the allocated conventions costs for the selected youth and then submit receipts to SILGA for reimbursement.

**POLICY DETAILS:**

1. Transportation:

- To pay compensation for air travel at the lowest available air fare; or
- To pay compensation for the use of private vehicles at the rate equivalent to that paid by the Province of British Columbia<sup>1</sup>, to a maximum of the lowest economy air fare.
- Only the driver is entitled to reimbursement for car mileage; the driver must submit the names of the passengers with the expense account.

2. Accommodation (due to weather conditions/distance travelled/  
other circumstances):

- To pay compensation for hotel rooms at cost and with a receipt required;  
or
- allowance of \$30.00 per night may be claimed (no receipts required).

3. Other Expenses:

---



- For all meetings and other authorized travel where required meals are not provided at the event, compensation for meals will be as follows:

Breakfast	\$15 including tips and tax
Lunch	\$25 including tips and tax
Dinner	\$35 including tips and tax

On the date of departure, travel must start before 7:00 am to claim breakfast; before 12:00 noon to claim lunch; and, on the date of return, travel must end after 6:00 pm to claim dinner.

- All other expenses occurred for hospitality expenses and other non-specified expenses shall be reimbursed at cost when receipts are provided, subject to Executive approval.

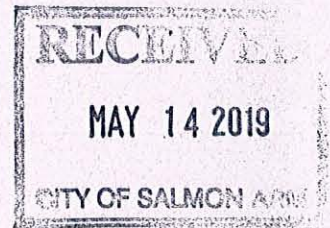

## Rogers informs Salmon Arm council of 2.6-metre antennae on downtown building as a courtesy

Salmon Arm council members expressed their appreciation for receiving notification from Rogers of cellular antennae to be erected on a building on Alexander Street.

At the city's May 6 planning and development services meeting, staff described the notification from Medallion Wireless, on behalf of Rogers Wireless. Rogers proposes to install "six initial antennas and one microwave, with room for three additional antennas in the future, comparable to what might be located on a cellular tower," according to a city planning report.

Coun. Louise Wallace Richmond said she has heard concerns from business about a big structure on the building and is pleased to see that it's not. She added she's happy to be informed.

The equipment will be placed on the roof of 320 Alexander St. NE, the building between the CIBC and Shuswap Clothing & Shoe Company, which houses several businesses including Crazy River Clothing Co. and the Montebello Dental Clinic.

No public consultation is required because the installation meets city criteria: locating antennas on an existing rooftop is a preferred location, as are areas designated commercial by the official community plan. Also, the proposed antennae are 2.61 metres in height and will extend 2.31m above the existing roof's parapet, which is less than the three-metre maximum recommended.

Marshall Rasmussen of Medallion Wireless attended the meeting and described the proposal as a minor installation.

Kevin Pearson, the city's director of development services, noted the company could go ahead and put the antennae on the roof without coming to the city.

"This is a courtesy."

Coun. Chad Eliason also appreciated the notification and credited the work the city has already done on cell tower installations with making the process straightforward.

"We did a lot of work on cell towers and cell tower installations, so when they come and want to work with us, there's not much to be done... I think we've done three cell towers in my time here."

He also said he thinks adding more capacity for cell service, which will increase time for productivity, is important for the downtown.

In a letter to the city, Rasmussen wrote that the purpose of the site is to respond to the growing demand for wireless voice and data communication services, such as mobile broadband and video service for use on smartphones, computer tablets and laptops.

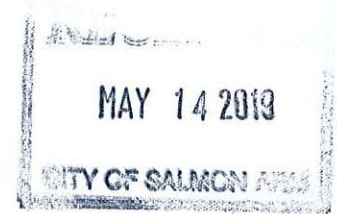
Mayor Alan Harrison pointed out that the antennae on the downtown firehall across from city hall are significantly taller than the ones proposed for Alexander Street.

Salty Dog weekend of events now includes: Friday night trail ride and BBQ, The Salty Street Fest Saturday, Salty Dog 6 Hour Enduro race on Sunday.

On Saturday May 11 Salty Street Fest event happened Downtown Salomon Arm. Live music, run bike parade, hulla hoops, clowns, face painting & street performers, bike swap, bike co's set up with cool gear, local tourism booths, all creating smiles and lots of fun! This year's Street Fest was another great community event supported by City of Salmon Arm, Down Town Salmon Arm, Shuswap Tourism, Salmon Arm Chamber, Shuswap Cycling Club, Shuswap Trail Alliance, Economic Development Society. With direct contributions from WaterWay HouseBoat Vacations, DeMilles, Skookum Cycle, Shuswap Pie Co, Candy Vault, Silver Star & Sun Peaks Resorts, and Shuswap Events. Salty Dog Weekend is one of only a few Bike events in BC that annually attracts major bike industry leading vendors. OPEN LETTER TO MAYOR HARRISON AND THE SALMON ARM CITY COUNCIL

Salmon Arm  
May 20, 2019

Re: Sustainable shopping bag plan

Dear Mayor and Council:

On April 23, I attended the Salmon Arm City Council meeting on their idea to ban single-use plastic bags. Local business representatives present agreed with the idea, just needing time to use up current bags. I presented several samples of washable fabric bags, created locally from clean recycled materials to be sold by donation to The Smile Mission Oral Health Outreach Society, which is a local registered charity raising funds to lower barriers to accessing basic dental care in Salmon Arm. The meeting concluded with the Mayor and Council deciding to acquire 8- or 9000 multiple-use bags from (China?), to be distributed to households in Salmon Arm.

In hindsight, I question the wisdom of using Salmon Arm money to buy bags from China that will still be made with plastic. China's environmental regulations are less stringent, and those bags will still be in our landfill hundreds of years from now: this is contrary to the whole point of moving away from plastic. Getting things cheaper from China does not count all the costs, and our goal here is to stop polluting. Further: the plastic-coated multiple-use grocery bags do not survive washing well and, as any cashier will tell you, they get gross after a while. Using those plastic bags to promote Salmon Arm will be sending the wrong message: that we are cheap, short-sighted and do not care about the long-term effect of products we (cause to) produce.

Why not use what we have right here? We have an alternative that will send the right message. How about expanding the Smile Mission fabric bag project already in progress, which will give Salmon Arm residents unique, washable and long-term reusable shopping bags, employ local people and support improved access to dental care, and with that, population health? Here is potential for a new, clean industry right here in Salmon Arm. We start, and lots of towns will want this.

I already started by creating a sewing room downtown, we can create any bag the City wants out of locally sourced materials and there is lots of excellent fabric around that can be re-purposed for this. The Smile Mission fabric bag project has been well-received, "bags supporting dental care" are available locally and residents have come forward with cheers, material supports and offers to help.

The Smile Mission Oral Health Outreach Society is a Registered Charity helping local residents who have financial barriers to access dental treatment with dignity in regular clinics. Improving oral health improves population health, which makes this a win/win for everybody. Can we talk?

- Support communities that have collaborative capacity in place and are ready to:
  - develop and/or coordinate a Regional Food Security Network
  - develop and implement a food security plan

#### **Eligible Applicants**

- First Nations governments and organizations
- Local governments
- Schools or school districts
- Non-profit organizations
- Community coalitions or councils

#### **Funding Available**

There is a total of **\$90,000** of funding available. The maximum amount available per grant is **\$15,000**.

*\*Note that we aim to distribute funding across the **IH region** whenever possible, depending on the applications we receive. We also take into consideration which communities have and have not received significant CFAI funding in recent years when reviewing applications of similar strength.*

### Single Year Project Types

Examples of eligible initiatives:

- food action projects that involve multi sector partnerships, and where projects demonstrate strong potential to build connections, partnerships and sustainability
- hosting community engagement event(s) to initiate discussions or collaboration opportunities
- building the capacity or reach of an existing initiative

### To apply for funding

Please submit a proposal (3 pages maximum plus 1 page budget, no smaller than 11 point font) including:

- Explanation of how funds will be used including how the proposed activity meets **at least one** of the CFAI goals and how the application aligns with other aspects of this year's intention for the single year grants
- Statement of how the activity will address a relevant local/regional issue
- Explanation of the role of stated partners involved, including the Interior Health Public Health Dietitian in your region
- Identify whether the activity is connected to current/ongoing initiative(s) or a new and emerging idea
- How the proposal will build capacity, collaboration, connections and relationships
- Explanation of how activity will be evaluated (ie. expected measurable outcomes, appropriate measurement tools or methods)
- Statement of sustainability (ie. plans to continue with work after CFAI funding period)
- A letter of support (LOS) from at least one partner agency, local or First Nations government, or other applicable group is required. The LOS should demonstrate the partner's engagement and expected contributions to the proposed project.
- Budget (*see template on next page*). Please note: proposals demonstrating reasonable in-kind contributions and committed monetary contributions from the host agency are preferred.
