

**CITY OF SALMON ARM  
PUBLIC NOTICE**

**TAKE NOTICE** that pursuant to Bylaw No. 3816 cited as “City of Salmon Arm Homely Water Reservoir – Cell No. 2 Loan Authorization Bylaw No. 3816”, the Council of the City of Salmon Arm proposes to borrow \$2,040,000.00 to proceed with the following capital works:

1. Undertake the design and construction of Homely Water Reservoir – Cell No. 2; and
2. The amount proposed to be borrowed to finance the design and construction of Homely Water Reservoir – Cell No. 2 shall be by debenture and is \$2,040,000.00, repayable not later than Twenty (20) years from the issue of such debenture.

The City is planning to twin the existing Homely (Zone 1) Water Reservoir to add storage capacity to the water distribution system. The project involves the expansion of the existing reservoir to double its capacity. The design will include a secondary disinfection system which will help to resolve the issue of maintaining acceptable chlorine residuals in the outer limits of the reservoir distribution area. The construction of a second reservoir will ensure that the water system adequacy, reliability and compatibility with the existing and future facilities

**AND FURTHER TAKE NOTICE** that pursuant to the provisions of Sections 179 and 180 of the Community Charter, the Council of the City of Salmon Arm may undertake the financing of the design and construction of Homely Water Reservoir – Cell No. 2 unless, within 30 days of the publication of the second notice in the Salmon Arm Observer, that being February 24, 2010, at least 10% (1,327) of the electors requesting Council not to proceed with the borrowing of \$2,040,000.00 for the design and construction of Homely Water Reservoir – Cell No. 2 (Bylaw No. 3816), unless it is approved by assent of the electors. If less than 10% (1,327) of the electors request Council not to proceed with the borrowing of \$2,040,000.00 for the design and construction of Homely Water Reservoir – Cell No. 2 (Bylaw No. 3816) unless it is approved by assent of the electors, the Council of the City of Salmon Arm may adopt City of Salmon Arm Homely Water Reservoir – Cell No. 2 Loan Authorization Bylaw No. 3816.

Any elector wishing to request that Council not proceed with the borrowing of \$2,040,000.00 for the design and construction of Homely Water Reservoir – Cell No. 2 (Bylaw No. 3816) unless it is approved by assent of the electors must sign an Elector Response Form. Copies of Elector Response Forms are available at the City of Salmon Arm.

**Instructions to Petitioners:**

The Community Charter of the Province of British Columbia requires that in order for an Elector Response to be valid:

1. The person signing the petition is an eligible elector of the City of Salmon Arm.
2. Must include full name, residential address and signature of the elector.
3. Must be signed by at least 10% (1,327) of the electors of the City of Salmon Arm.
4. If signing as a Property Elector (non-resident), full residential address of property in Salmon Arm must be entered, as well as your residential address.

This petition may be submitted by mail or person to the City of Salmon Arm by no later than 4:00 p.m. on Wednesday, March 31, 2010, to the mailing address noted below. Postmarks will not be accepted as date of submission.
