Dear Mayor Harrison and Members of City Council

It was with profound dismay that our club members heard about the cutting down of a large area of trees at 2391 26th Avenue NE early in June. There are so many reasons why this illegal act must be condemned and significant consequences be imposed.

From the point of view of the natural habitat, spring is a time of nesting and the arrival of young. We can be sure that eggs and nestlings of birds were destroyed. Other animals would have considered that space their home. Reptiles, amphibians and mammals would have been impacted. In respect of the birds, the nesting time is an important consideration in the Migratory Birds Act. The BC Wildlife Act also has requirements that should have been taken into consideration before any cutting was done.

Like other citizens we are concerned about the climate change that has impacted us all and the need to conserve the trees that store carbon and use up carbon dioxide and generally act as the lungs of the planet. Trees must be conserved for their proven ability to lower local temperatures through the provision of shade and water.

Trees help to control the erosion on slopes and the runoff of meltwater or rain that can cause landslides or flooding and impact our infrastructure.

In addition, there is the aesthetic value of trees that has proved to be important for the mental health for our citizens.

We have heard that the property owners intend to subdivide. This, however, does not mean they can ignore legislation.

We ask that the city pursue all avenues to ensure that the guilty persons in this action be held responsible and pay the price for breaking the bylaw.

#### Dear Mayor and Council:

We are writing to ask the City of Salmon Arm to show its support for local news media by following the example of the Province of British Columbia and the Federal and Quebec governments and stop all advertising with Meta platforms Facebook and Instagram. We are also asking that you direct staff to divert the portion of your advertising budget spent on Meta to invest in local news media.

The Salmon Arm Observer needs your assistance to safeguard the ongoing ability of our journalists to continue to report freely on matters of public interest. Canadian media is facing unprecedented challenges that are affecting our ability to continue to publish journalism that readers can trust. Our huge audience growth over the past ten years isn't reflected in the advertising investment by governments and private corporations. As audience numbers continued to grow at an unprecedented pace, media investment supporting Canadian news organizations has dropped from 23.1 per cent in 2014 to a mere 5.7 per cent in a five-year span.

With the passage of Bill C-18, the Online News Act, Meta has announced it will remove all accredited news content from its pages rather than negotiate a fair deal with Canadian news media. Google has also indicated that unless its demands are met, it will deindex news organizations, making it impossible for Canadians to find local news sources using Google search.

More than ever, democratic principles are under attack from bad actors that spread information at a rate only made possible by algorithm-driven mega-companies like Meta that control almost every facet of our information networks.

Trusted news sources like The Salmon Arm Observer are an important indicator of a thriving democracy. We've gained huge audiences by adding balance in an increasingly unbalanced world and by helping to communicate the work being done by many non-profit organizations, service clubs, business associations and individuals to build a better community for all. Black Press Media averages

more than 4.1 million unique views a month on our news sites including The Salmon Arm Observer and we employ more BC-based journalists that any other BC news organization.

We ask that the City of Salmon Arm use its economic clout and join its provincial and Canadian counterparts and governments around the world that are taking a stand at this crucial time in history to proclaim that the power to decide how and what information is shared isn't the purview of an elite group of foreign-based players, but should be in the hands of democratic governments and the people who elect them.

We thank you for your time and we trust the City of Salmon Arm will side with Canadian news media and the democratic principles that have shaped our country.

RE: Traffic safety in the community of Canoe

Dear Mayor and Council and the Traffic Safety Committee:

Canoe is generally an idyllic community, with residents of all ages, from older adults to families with young children. Although Canoe is small, its streets are often bustling with people riding bikes and walking dogs, youngsters skateboarding and playing basketball in driveways, families strolling to the beach. For the most part, motor vehicle drivers in Canoe are respectful and watch for kids, cats, cyclists, and other road users. However, we're not without our traffic issues, and we're hoping that Mayor and Council and the Traffic Safety Committee are giving this some thought given the substantial growth expected in our community in the coming years—with up to 120 new townhouse units planned for Canoe Beach Drive and up to 120 new houses planned for Park Hill Estates, in addition to the smaller "Turtle Ridge" subdivision and new RV lots for sale between the elementary school and the highway.

We're looking at potential growth in almost every part of our community without the infrastructure to support it. Traffic-wise, we have a sprinkling of controlled intersections (stop signs and crosswalks) and a few sidewalks. Other than those marking the school zone, there are no posted speed limit signs on the main streets of Canoe. Is the speed limit 50, 40, 30 km/h?¹ Some people drive as though the absence of posted speeds makes Canoe the local equivalent of the Autobahn. On weekend evenings in particular, vehicles can be heard revving and screeching up 50th St NE (a residential street) and along Canoe Beach Drive (also largely residential). Canooligans' restaurant, while a great addition to the community, is also bringing in more traffic and in some cases adding alcohol into the mix.

The City of Salmon Arm could help prepare Canoe for the anticipated influx of new residents and drivers with a well-planned traffic-calming strategy to keep our streets safe. Simply posting speed limit signs on 50th St NE, Canoe Beach Drive, and 70th Ave NE would be a great first step. Supplementing this signage (at least initially) with feedback signs that alert drivers to their actual speeds could help; as could even

<sup>&</sup>lt;sup>1</sup> There are precedents for reduced speed limits (40 km/h, 30 km/h, and even lower in some cases) for local roads, residential areas, and high-pedestrian zones in both smaller and larger communities in BC, Canada, and around the world. A 30 km/h residential street pilot was put forward in a 2019 UBCM resolution, and a June 2022 poll found that 72% of Southern BC residents would "definitely" (37%) or "probably" (35%) support 30 km/h speed limits in their own municipality (see links on the following page). Designation as a local road in the OCP and a reduced speed limit would be ideal in the busiest stretch of "main street" Canoe (50th Street NE) between Canoe Beach Drive and 70th Ave NE in particular.

occasional enforcement, which drivers are unconcerned about because it happens so rarely in Canoe. Crosswalks (possibly raised ones) in key locations would be useful too: from the seniors' centre walkway on 50th St NE across to the post office; from the walkway between 71st and 70th Aves NE across to the small park on 70th (residents have witnessed a number of close calls at this crossing over the years).

Ultimately, a forward-looking approach that seeks to resolve current traffic-related issues and prevent new ones associated with population growth and increased traffic in Canoe, coupled with traffic data collection (e.g., assessment of traffic volumes and speeds on the busiest roads in Canoe at different times of day and different days of the week) and an opportunity for community input could help to keep our streets safe and ensure that the needs and concerns of Canoe residents are addressed.

Downtown Salmon Arm, in partnership with Shuswap District Arts Council, Salmon Arm Economic Developments Society, and ROOTSandBLUES, is requesting pedestrian-use only of the SW portion of the 100 block of Hudson Avenue NE on Saturday, October  $14^{th}$ , from 8 am -11 pm for the second annual Loud and Proud concert. Day-of preparation for this event is extensive, including the installation of the performance stage and sound equipment, sound check, as well as set-up for the evening of activities. The requested closure is a smaller area than last year to help create a more condensed festival space and will cause little-to-no disruption of local business parking during set-up, the duration of the event, and take-down.

In addition, we are a requesting a one-time extension of the City's Noise Prevention Bylaw No. 2037 from 10:00 pm on Saturday, October 14, to 12:00 am Sunday, October 15.

Activities at this event will run from 4 pm - 10 pm and should include a live music concert and dance performances requiring a stage, space for both seated and standing audiences, exhibitor booths, portable toilets, and food truck vendors. 


