9.1 Heritage Plaque Program

City Staff informed CHC members that City Staff are looking into protocols for the heritage plaques. They will provide an update at the next meeting. The City's Communications team will be attending the next CHC meeting to answer questions about promoting heritage initiatives. CHC members reviewed and edited a draft letter to potential plaque recipients. City Staff will mail these letters to determine interest in the program.

9.2 Wright/Lund Pond

City Staff provided an update that a report will be going to Council on Monday April 14th recommending that Council approve the naming of the pond within John Lund Park as "Wright's Pond." City Staff will send the agenda and report to CHC members and others who shared correspondence on Friday. CHC members expressed the importance of notifying the public of the name change.

9.3 Heritage Register - New Statements of Significance

City Staff provided an update that the proposed additions to the Community Heritage Register were approved by Council on Monday March 10th. A formal letter along with the Statements of Significance were mailed to R.J. Haney Heritage Village and Museum.
