7. **NEW BUSINESS**

a) **Letter dated August 15, 2023 from Second Harvest Food Bank**

- Previous years the Second Harvest was permitted by a bylaw officer to display a Second Harvest printed parking pass. Vehicles displaying this pass would not receive parking tickets downtown
- Neither the DPC nor the City were aware of such agreement.
- A new bylaw officer issued tickets to vehicles displaying this permit during the summer
- Group discussion included:
  - Cathy Ingebrigston stated:
    - The Food Bank will be reducing their operational days from 3/week to 1/week.
    - Volunteers would utilize parking passes on Tuesday's and Wednesday's.
    - Generally 8 people would volunteer.
  - Bill Laird asked Travis Bartsch for Bylaw's position.
  - Travis Bartsch stated:

7. **NEW BUSINESS - continued**

a) **Letter dated August 15, 2023 from Second Harvest Food Bank - continued**

- Bylaw has no position whether to grant the permits or not, whatever direction the DPC provided is what will be followed.
- If permits were to be granted, formalization of the permit should be considered:
  - City should create a permit, which would include the year the permit was valid.
- DPC should determine how many permits will be granted.

THAT: Second Harvest be granted 8 permits which the City will create annually indicating the year of validity.

b) **Letter dated September 13, 2023 from Downtown Salmon Arm - representative**

Downtown Salmon Arm has appointed Claire Askew as a DSA representative after the resignation of Vera Chomyshen.

c) **Rogers Communication - installation of fiber optics cable in downtown**

G. Bau, City Engineer, stated that Rogers Communications' plan to install a new digital optic line downtown this year will not be proceeding.

d) **2024 Budget**

Rob Niewenhuizen advised that the 2024 budget will be presented during the next DPC meeting.

e) **Street Patios**

Gerald Foreman raised the following concerns in regard to street patios:

- As the patios open at 4:00pm, is it reasonable to accept the loss of parking spaces during the day to accommodate evening use?
- Do businesses that have patios pay extra taxes for the additional space they receive for their businesses? Bill Laird answered that annual rent is paid by the businesses that utilize street patios.

7. **NEW BUSINESS - continued**

f) **Alexander Street closure for events**

The possibility of closing Alexander Street to hold events was discussed

- o Downtown area does not have the number of streets available to keep traffic circulating effectively if a street is closed regularly.
- o Concern for Emergency Services to access the downtown core quickly could be compromised if a street was closed regularly.
- o Businesses may be affected by the loss of street parking in front of their stores.
- o A street was closed for the Farmer's Market previously, this did not work as well as hoped as the Market did not attract enough vendors to completely fill an entire street.
