TREE PERMITS GUIDE

This guide is not a legal document, it is intended only to assist you through the Tree Permit application <u>process</u>. Following the steps herein does not constitute approval of an application. While every care is taken in the preparation of this brochure, the City of Salmon Arm assumes no responsibility or liability with respect to its contents. The public is advised to review the applicable legislation and bylaws and conduct its own enquiries with Development Services staff.

WHEN DO I NEED A TREE PERMIT?

The Tree Protection Bylaw 4637 states that a tree may only be cut down or removed where its owner holds a valid and subsisting permit to do so.

A permit is required if and when you wish to remove trees to construct a building, driveway or septic field or if you wish to remove trees for development purposes.

WHEN IS A TREE PERMIT NOT REQUIRED?

If the land is assessed for agriculture, and tree removal is required for agricultural purposes, a permit is not required, but a notarized affidavit verifying the purpose of the tree removal must accompany an application.

Residential Parcels:

- 1,500 square metres (16,145 square feet) or less in area, no more than three (3) trees in any calendar year;
- Larger than 1,500 square metres (16,145 square feet) in area, and up to 0.4 hectares (43,056 square feet / 1 acre) in area, no more than six (6) trees in any calendar year;
- Larger than 0.4 hectare (1 acre), the removal of no more than 12 trees per hectare in any calendar year, to a maximum of 100 trees annually, regardless of the parcel size.

These exemption provisions **do not** include:

trees located on a slope of 30%;

 trees located within fifteen (15) metres of a watercourse.

A permit is **not required** if the tree is:

- have a circumference of less than 31.5 centimetres measured at 1.5 metres above the level of the ground;
- pose an obvious and immediate safety hazard.

A permit is not required for tree clearing for purposes of wildfire protection, provided the landowner has Advanced Home Assessment report under the Firesmart Program.

Every person who commits an offence against this bylaw is liable to a fine and penalty of not more than Two Thousand Dollars (\$2,000.00) for each offence.

MAKING APPLICATION

The Application form for tree cutting and removal can be obtained at the Planning Department. The application must include:

- an accurate sketch plan of the property drawn to scale, including a north arrow, correctly showing the locations, species and size (circumference of trunk at 1.5 metres above natural grade at base of tree) of all trees presently on the property that are subject to Tree Protection Bylaw 4637;
- the location of all abutting street and lanes.
- a current Title Search

LAND DEVELOPMENT & TREE REPLACEMENT

A Tree Permit can also be issued as part of a Development Permit, subdivision approval or a Building Permit. The same information requirements apply.

All development, subdivision and building permits must ensure that trees on the affected property are replaced and meet the following requirements:

BIRDS & NESTS

Care should be taken to ensure that there are no bird's nests in trees proposed to be cut, and a survey conducted.

Active nests for Herons and Pileated Woodpeckers cannot be disturbed at any time. For Herons, the nest may be considered abandoned after it is vacant for 24 months, and for Pileated Woodpeckers the time is 36 months.

For other birds, permits to cut may be delayed to accommodate the least risk windows for other birds nests, according to the following table:

| Species | Least Risk Window |
|---|-------------------|
| Raptors (eagles, hawks, falcons & owls) | Aug 15 – Jan 30 |
| Goshawk | Aug 30 – Mar 15 |
| Herons | Aug 15 – Jan 30 |
| Other Birds | Aug 1 – Mar 31 |

REVIEW OF THE APPLICATION

The Development Services Department may inspect the parcel of land. An assessment may be made to determine the location, size, condition and species of the trees.

When the Development Services Department is satisfied via site inspection or documentation provided by the applicant that the site can safely accommodate the cutting of the trees, the permit can be issued. The applicable fee for the permit must be paid prior to issuance.

If a permit is refused, then the applicant has the option of asking Council to reconsider the decision.

Replacement trees shall have a minimum height
of 2.0 metres when planted, be planted with a
distance of no less than 2.0 metres between
individual trees, and be of a species from an
appropriate species listing provided by the City
and capable of growing to a height of no less than
9.0m in height when mature.
